The Alderney (Application of Legislation) (Contributory Pensions) Ordinance, 1962

THE STATES LEGISLATION COMMITTEE, in exercise of the powers conferred upon them by paragraph (3) of Article sixty-six of the Reform (Guernsey) Law, 1948, section one of the Alderney (Application of Legislation) Law, 1948, and of all other powers thereunto them enabling, hereby order:—

1. The Law and the Ordinances set out in the left-hand column of the Schedule to this Ordinance shall, subject to the modification set out in the right-hand column of that Schedule, have effect in the Island of Alderney as they have effect in the Island of Guernsey:

Legislation to have effect in Alderney.

PROVIDED that any reference to any enactment in that Law or in any of those Ordinances as ex-

tended to the Island of Alderney by this Ordinance shall be construed as a reference to that enactment as extended to that Island by any other enactment including this Ordinance.

Citation and commencement.

2. (1) This Ordinance may be cited as the Alderney (Application of Legislation) (Contributory Pensions) Ordinance, 1962.

(2) This Ordinance shall come into force on the first day of April, nineteen hundred and sixty-two.

SCHEDULE

Section one.

The Contributory Pensions
(Variation of Rates of Contributions and Benefits)
(Guernsey) Law, 1961.

The Contributory Pensions
(Increased Rates of Contributions and Benefits) Ordinance,
1962.

In subsection (1) of section one, in the definition of the expressions "Guernsey", the words "the Islands of Herm and Jethou" are hereby repealed and the words and comma "the Islands of Alderney, Herm and Jethou" are hereby substituted therefor.

The Export of Tomatoes (Packing and Grading) (Amendment) Ordinance, 1962

THE STATES, on the representations of the States Committee for Horticulture, hereby order:—

1. Subsection (3) of section two of the Export of Tomatoes (Packing and Grading) Ordinance, 1961, is hereby repealed and the following subsection is hereby substituted therefor—

Amendment
to 1961
Ordinance.

“(3) The Committee may, from time to time, by order prohibit the delivery of tomatoes to the Board for export otherwise than in containers designed to contain six pounds of tomatoes or otherwise than in containers designed to contain twelve pounds of tomatoes.”

Citation.

2. This Ordinance may be cited as the Export of Tomatoes (Packing and Grading) (Amendment) Ordinance, 1962, and this Ordinance and the Export of Tomatoes (Packing and Grading) Ordinance, 1961, may be cited together as the Export of Tomatoes (Packing and Grading) Ordinances, 1961 and 1962.
