The Alderney Occupiers' Rate (Amendment) Ordinance, 1994

THE STATES OF ALDERNEY, in pursuance of their Resolution of the 7th day of September, 1994, and in exercise of the powers conferred upon them by section 3 of the Alderney (Application of Legislation) Law, 1948, as amended^a, hereby order: –

Amendment.

1. In section 3 of the Alderney Occupiers' Rate Ordinance, 1949, as amended^b –

(a) after the words "the occupier of that property" insert the following –

"(or, in cases where there is no occupier, by the person who was the owner thereof)",

(b) for the words "on the first day of July" substitute "at midnight on the 30th April".

NOTE

In accordance with the provisions of the Taxation of Real Property (Enabling Provisions) (Guernsey and Alderney) Law, 2005, section 4(c) and section 4(h), with effect from 13th November, 2006, this enactment is one of those that the States may repeal, amend, extend, adapt, modify or disapply by

Rate for 1995.

2. The occupiers' rate to be levied on any property in the calendar year 1995 pursuant to section 3 of the Alderney (Application of Legislation) Law, 1948, as amended, shall be levied at the rate of 185 pence in the pound of the rateable value of the property.

Citation.

3. This Ordinance may be cited as the Alderney Occupiers' Rate (Amendment) Ordinance, 1994.
