The Board of Employment, Industry and Commerce (Transfer of Functions) Ordinance, 1996.

THE STATES, in pursuance of their Resolution of the 31st day of January, 1996(a), and in exercise of the powers conferred upon them by section 1 of the Public Functions (Transfer and Performance) (Bailiwick of Guernsey) Law, 1991(b), hereby order:-

Transfer of functions to Board of Industry.

1. The functions of the States Board of Employment, Industry and Commerce and its President under the enactments set out in Schedule 1 are transferred respectively to the States of Guernsey Board of Industry and its President.

Savings and transitional provisions.

2. Anything done before the date of the commencement of this Ordinance or in the process of being done on that date by or in relation to the States Board of Employment, Industry and Commerce or its President under any of the enactments set out in Schedule 1 shall have effect as if done or (as the case may be) may be continued by or in relation to the States of Guernsey Board of Industry or (as the case may be) its President.

Amendments.

3. The enactments set out in Schedule 2 are amended as therein mentioned.

Repeals.

4. The Transfer of Functions Ordinance, 1991(c) is repealed.

Interpretation.

Citation.

6. This Ordinance may be cited as the Board of Employment, Industry and Commerce (Transfer of Functions) Ordinance, 1996.
