**The Cadastre Law, 1947 Rules (Amendment)  
Ordinance, 1968**

**THE STATES**, in pursuance of their Resolution of the thirty-first day of January, nineteen hundred and sixty-eight, and in pursuance of the powers now vested in them by Article 12 of the Cadastre Law, 1947<sup>a</sup>, and of all other powers enabling them in that behalf, hereby order: –

**Amendments to Ordinance of 1948.**

1. The Ordinance (1948) enacting the Cadastre Law, 1947 Rules, as amended<sup>b</sup>, is hereby further amended, as follows –

- (a) in sub-category (d) of category F in rule four of the Schedule thereto the word "Department" is hereby repealed and the word "Board" is hereby substituted therefor,
- (b) category F in rule five of the Schedule thereto is hereby repealed and the following category is hereby substituted therefor –

*Consolidated text*

The annual rental value, as respects the year nineteen hundred and sixty-eight, shall be the sum of seven thousand pounds sterling.

Sub-Category (b)

The annual rental value, as respects the year nineteen hundred and sixty-eight, shall be the sum of seventeen thousand pounds sterling.

Sub-Category (c)

The annual rental value, as respects the year nineteen hundred and sixty-eight, shall be the sum of fifteen thousand pounds sterling.

Sub-Category (d)

The annual rental value, as respects the year nineteen hundred and sixty-eight, shall be the sum of sixty thousand pounds sterling.

(2) Sub-Categories (a) to (d) both inclusive

The annual rental value, as respects the year nineteen hundred and sixty-nine and the annual rental value as respects each year thereafter, shall be calculated by multiplying the annual rental value as respects the year nineteen hundred and sixty-eight by a fraction of

which –

- (a) the numerator is the Basic Year Output increased or decreased, as the case may be, by two-fifths of the difference between the Basic Year Output and the Actual Year Output, and
  - (b) the denominator is the Basic Year Output.
- (3) For the purposes of making any calculation in pursuance of the provisions of the last preceding paragraph the following expressions have the meanings hereby respectively assigned to them, that is to say –

**"Actual Year Output"** means –

- (a) as respects the Guernsey Gas Light Company Limited, the total amount of gas in cubic feet certified to the Cadastre Committee by or on behalf of the said Company as having been sold by the said Company during the year immediately preceding the year in respect of which the calculation is being made,
- (b) as respects the States of Guernsey

Water Board, the total amount of water in gallons certified to the Cadastre Committee by or on behalf of the said Board as having been distributed by the said Board during the year immediately preceding the year in respect of which the calculation is being made,

(c) as respects the States of Guernsey Telephone Council, the total number of calls certified to the Cadastre Committee by or on behalf of the said Council as having been initiated by subscribers in Guernsey of which the whole of the revenue accrued to the said Council during the year immediately preceding the year in respect of which the calculation is being made,

(d) as respects the States of Guernsey Electricity Board, the total amount of electric energy in kilowatt hours certified to the Cadastre Committee by or on behalf of the said Board as having been sold by the said Board during the year immediately preceding the year in respect of which the calculation is being made;

**"Basic Year Output"** means –

- (a) as respects the Guernsey Gas Light Company Limited, the total amount of gas in cubic feet certified to the Cadastre Committee by or on behalf of the said Company as having been sold during the year nineteen hundred and sixty-seven,
  
- (b) as respects the States of Guernsey Water Board, the total amount of water in gallons certified to the Cadastre Committee by or on behalf of the said Board as having been distributed by the said Board during the year nineteen hundred and sixty-seven,
  
- (c) as respects the States of Guernsey Telephone Council, the total number of telephone calls certified to the Cadastre Committee by or on behalf of the said Council as having been initiated by subscribers in Guernsey of which the whole of the revenue accrued to the said Council during the year nineteen hundred and sixty-seven,
  
- (d) as respects the States of Guernsey Electricity Board, the total amount of electric energy in kilowatt hours

certified to the Cadastre Committee by or on behalf of the said Board as having been sold by the said Board during the year nineteen hundred and sixty-seven." <sup>1</sup>

**NOTE**

**Citation.**

2. (1) This Ordinance may be cited as the Cadastre Law, 1947 Rules (Amendment) Ordinance, 1968.

(2) This Ordinance, the Ordinance (1948) enacting the Cadastre Law, 1947 Rules and the Ordinance (1948) amending the Cadastre Law, 1947 Rules may be cited together as the Cadastre Law Rules Ordinances, 1948 to 1968.
