The Companies (Alderney) Law (Fees) Ordinance, 2011

THE STATES OF ALDERNEY, in exercise of its powers conferred upon them by sections 159 and 164 of the Companies (Alderney) Law 1994 (a), hereby order:-

Increase of late filing fee.

1. In section 107(7) of the 1994 Law –
 - (a) in paragraph (a) for “£57” substitute “£59”;
 - (b) in paragraph (b) for “£113” substitute “£116”;
 - (c) in paragraph (c) for “£169” substitute “£174”.

Increase of fee to restore to register.

2. In section 108(4)(b) of the 1994 Law, for “£169” substitute “£174”.

Increase of certain fees under 1994 Law.

3. In section 159(1) of the 1994 Law -
 - (a) in paragraph (a) for “£113” substitute “£116”;
 - (b) in paragraph (b) for “£36” substitute “£37”;
 - (c) in paragraph (c) for “£36” substitute “£37”;
 - (d) in paragraph (d) for “£24” substitute “£25”;
 - (e) in paragraph (e) for “£24” substitute “£25”;
 - (f) in paragraph (f) for “£57” substitute “£59”;
 - (g) in paragraph (g) for “£57” substitute “£59”;
 - (h) in paragraph (h) for “£36” substitute “£37”;
 - (i) in paragraph (i) for “£36” substitute “£37”;
 - (j) in paragraph (j) for “£24” substitute “£25”;
 - (k) in paragraph (k) for “£24” substitute “£25”;
 - (l) in paragraph (l) for “£57” substitute “£59”;
 - (m) in paragraph (m) for “£41” substitute “£43”.

Other fees for purposes of 1994 Law.

4. Upon the occurrence in relation to a company of any of the following events under the 1994 Law, the company or as the case may be the applicant shall pay to the Registrar the following fees:
- (a) upon the delivery to the Registrar of a return of allotments under section 40, £32;
 - (b) upon the delivery to the Registrar of a copy resolution under section 53 altering the company's share capital, £32;
 - (c) upon the giving of notice to the Registrar under section 54(5) of the redemption of redeemable preference shares, £32;
 - (d) for the lodging with the Registrar under section 150 of an inspectors' report, £32;
 - (e) for the delivery by the directors under paragraph 9 of Schedule 7 of a certificate required to be signed under paragraph 5,6 or 8 of that Schedule, £32;
 - (f) for an application to the Registrar for the entry in the Register of Companies of a copy of any order of the Court, £32;
 - (g) for the delivery to the Registrar of a copy of a special resolution for entry in the Register of Companies, £32;
 - (h) for an inspection of the Register of Companies, or of the records in respect of a company which has been struck off or otherwise dissolved, £12 per company; and for the purposes of this paragraph the Register and records shall be deemed to include the company's memorandum and articles, its certificate of registration, its annual returns, its special resolutions and all other documents required by law –
 - (i) to be given to the Registrar in relation to the company; or
 - (ii) to be entered by the Registrar in the Register of Companies;
 - (i) for the supply by the Registrar of a photocopy of any document described in paragraph (h), £1.20 per A4 side;
 - (j) for the supply of any document described in paragraph (h) by facsimile, £14;
 - (k) for an application to change the Director or Company Secretary, £25.

Interpretation.

5. (1) In this Ordinance the "**1994 Law**" means the Companies (Alderney) Law, 1994, and, unless the context requires otherwise, words and phrases used for the purpose of this Ordinance have the same meaning as used for the purpose of the 1994 Law.
- (2) The Interpretation (Guernsey) Law, 1948(b) shall apply to the interpretation of this Ordinance.
- (3) Any reference in this Ordinance to an enactment is a reference thereto as from time to time amended, repealed and re-enacted (with or without modification), extended or applied.

Repeals.

6. The Companies (Alderney) Law (Fees) Ordinance, 1995, the Companies (Alderney) Law (Fees) Ordinance, 2007, the Companies (Alderney) Law (Fees) Ordinance, 2008, the Companies (Alderney) Law (Fees) Ordinance, 2009, and the Companies (Alderney) Law (Fees) Ordinance 2010 are repealed.

Citation.

7. This Ordinance may be cited as the Companies (Alderney) Law (Fees) Ordinance, 2011.

Commencement.

8. This Ordinance shall come into force on 1st January 2012.
