Coming into operation 1st January 2008

THE COMPANIES (ALDERNEY) LAW (FEES) ORDINANCE, 2007

THE STATES OF ALDERNEY, in exercise of its powers conferred upon them by sections 159 and 164 of the Companies (Alderney) Law 1994(a), hereby order:-

4. Upon the occurrence in relation to a company of any of the following events, the company or as the case may be the applicant shall pay to the Register the following fees:
- (a) upon the deliver to the Register of allotments under section 40, £25;
 - (b) upon the deliver to the Register of a copy resolution under section 53 altering the companys share capital, £25;
 - (c) upon the giving of notice to the Register under section 54(5) of the redemption of redeemable preference shares, £25;
 - (d) for the lodging with the Register under section 150 of an inspectors report, £25;
 - (e) for the delivery by directors under paragraph 9 of Schedule 7 of a certificate required to be signed under paragraph 5, 6 or 8 of that Schedule, £25;
 - (f) for an application to the Registrar for the entry in the Register of Companies, £25;
 - (g) for the delivery to the Registrar of a copy of a special resolution for entry in the Register of Companies, £25;
 - (h) for an inspection of the Register of Companies, or of the records in respect of a company which has been struck off or otherwise dissolved, £10 per company; and for the purpose of this paragraph the Register and records shall be deemed to include the companys memorandum and articles, its certificate of registration, its annual returns, its special resolutions and all other documents required by law—
 - (i) to be given to the Registrar in relation to the company; or
 - (ii) to be entered by the Registrar in the Register of Companies;
 - (i) for the supply by the Registrar of a photocopy of any document described in paragraph (h), £1 per A4 side;
 - (j) for the supply of any document described in paragraph (h) by facsimile, £10.

**Other fees

5. (1) In this Ordinance the **1994 Law** means the **Interpretation Companies (Alderney) Law 1994** and unless the context requires otherwise, words and phrases used for the purpose of this Ordinance have the same meaning as used for the purpose of the 1994 Law.
- (2) The Interpretation (Guernsey) Law 1948(b) shall apply to the interpretation of this Ordinance.
- (3) Any reference in this Ordinance to an enactment is a reference therto as from time to time amended, repealed and re-enacted (with or without modification), extended or applied.
6. This Ordinance may be cited as the Companies (Alderney) Law (Fees) Ordinance 2007. **Citation**
7. This Ordinance shall come into force on 1st January 2008. **Commencement**
