## The Dog Tax (Guernsey) Ordinance, 1990

THE STATES, in pursuance of their Resolution of the 26<sup>th</sup> day of July, 1990<sup>a</sup>, and in exercise of the powers conferred upon them by section 1 of the Dog Licences (Guernsey) Law, 1969<sup>b</sup>, hereby order: –

### Dog Tax.

1. (1) The annual dog tax payable under the provisions of section 1(1) of the Dog Licences (Guernsey) Law, 1969, (hereinafter referred to as "**the Law of 1969**") shall be [£10].

(2) The dog tax payable upon a licence being taken out during the period commencing on the 1<sup>st</sup> day of July and ending on the 31<sup>st</sup> day of December in any year under the provisions of section 1(2) of the Law of 1969 shall be [£5].

3. (1) This Ordinance may be cited as the Dog Tax (Guernsey) Ordinance, 1990.
