## Ordinance of the States **LVI**

**1976**

Made ... .. 24th November, 1976.

### **The Fishing by Diving (Licensing) (Amendment) Ordinance, 1976**

THE STATES, in pursuance of their Resolution of the twenty-ninth day of September, nineteen hundred and seventy-six, hereby order:—

1. The Fishing by Diving (Licensing) Ordinance, 1975 (hereinafter referred to as “the principal Ordinance”) (a), is hereby amended as follows:— **Amend-

- (a) in the Arrangement of Sections thereof in the entries relating to sections one, two and three and in the marginal notes to sections one, two and three thereof the words “ormers and” are repealed;
- (b) in sections one, two, three, five, ten, fourteen, fifteen, eighteen and nineteen thereof the words “ormer or”, wherever those words occur, are repealed;
- (c) in sections one, two, three, five, eight and fifteen thereof the words “ormers or”, wherever those words occur, are repealed;

- (d) in sections one, two, three, five, eight and fifteen thereof the words and commas “, as the case may be,”, wherever those words and commas occur, are repealed;
- (e) in subsection (1) of section fifteen thereof the words “one hundred pounds” are repealed and the words “two hundred pounds” are substituted therefor;
- (f) in subsection (1) of section eighteen thereof the definition of the expression “this Island” is repealed and the following definition is substituted therefor—  
 ““this Island” means any of the Islands of Guernsey, Herm and Jethou and includes the islets and rocks and the territorial waters adjacent thereto;”;
- (g) in the Schedule thereto paragraphs 1 and 3 thereof are repealed;
- (h) the Schedule thereto is repealed and the Schedule set out in the Schedule to this Ordinance is substituted therefor.

**Citation.**

2. This Ordinance may be cited as the Fishing by Diving (Licensing) (Amendment) Ordinance, 1976.

**Collective title.**

3. This Ordinance and the principal Ordinance may be cited together as the Fishing by Diving (Licensing) Ordinances, 1975 and 1976.

**Commencement.**

4. (1) The provisions of this Ordinance, other than the provisions of paragraph (h) of section one thereof, shall come into force on the twenty-fourth day of November, nineteen hundred and seventy-six.

(2) The provisions of paragraph (h) of section one of this Ordinance shall come into force on the first day of April, nineteen hundred and seventy-seven.
