**The Gambling (Betting) (Amendment) Ordinance, (No. XXXVI  
—1977)**

THE STATES, in exercise of the powers conferred upon them by section two of the Gambling (Guernsey) Law, 1971(a), as amended(b), and in pursuance of their Resolution of the twenty-ninth day of September, nineteen hundred and seventy-seven, hereby order:—

1. The Gambling (Betting) Ordinance, 1973(c), as amended(d), (hereinafter referred to as “the principal Ordinance”) is hereby further amended of 1973. as follows:—

- (a) in subsection (7) of section twelve thereof the words "section twenty-four" are repealed and the words "section twenty-seven" are substituted therefor;
- (b) in subsection (8) of section twelve thereof the words "section twenty-five" are repealed and the words "section twenty-eight" are substituted therefor;
- (c) in section twenty-seven thereof the words "four pounds" are repealed and the words "eight pounds" are substituted therefor;
- (d) in subsection (1) of section twenty-eight thereof—
  - (i) in paragraph (a) the words "one hundred pounds" are repealed and the words "two hundred pounds" are substituted therefor;
  - (ii) in paragraph (b) the words "two hundred pounds" are repealed and the words "four hundred pounds" are substituted therefor;
  - (iii) in paragraph (c) the words "fifty pounds" are repealed and the words "one hundred pounds" are substituted therefor;
- (e) in subsection (1) of section thirty-eight thereof in the definition of the expression "the Channel Islands Lottery" the words and brackets "the Channel Islands Lottery (Bailiwick of Guernsey)" are repealed and the words and brackets "the Gambling (Channel Islands Lottery) (Bailiwick of Guernsey)" are substituted therefor;
- (f) in paragraph two of the Second Schedule thereto the words "five pounds" are repealed and the words "ten pounds" are substituted therefor;

(g) in sub-paragraph (a) of paragraph two of the Third Schedule thereto the words "five pounds" are repealed and the words "ten pounds" are substituted therefor. 1977.

2. This Ordinance may be cited as the Gambling (Betting) (Amendment) Ordinance, 1977, and this Ordinance and the principal Ordinance may be cited together as the Gambling (Betting) Ordinances, 1973 and 1977. Citation and collective title.
