—1986)****The Gambling (Channel Islands Lottery)
(Bailiwick of Guernsey) (Amendment)
Ordinance, 1986**

THE STATES, in pursuance of their Resolution of the 30th day of July, 1986, and in exercise of the powers conferred upon them by section 2 of the Gambling (Bailiwick of Guernsey) Law, 1974(a), and of all other powers enabling them in that behalf, hereby order:—

1. The Gambling (Channel Islands Lottery) (Bailiwick of Guernsey) Ordinance, 1975, as amended(b) (hereinafter referred to as “the principal Ordinance”), is hereby further amended as follows:—

(a) section 6(4) is deleted and the following subsection substituted therefor—

“(4) Every draw shall be conducted in the presence of—

(a) the presiding officer; and

(b) at least one other member of the Committee, or a person appointed by the Committee for the purpose of assisting in the conduct of the draw, who, for the purposes of this section, shall be deemed to be a member of the Committee.”;

(b) in section 6(6)(d) thereof, the words “subsection (9) of this section” are repealed and the words “section 10(1)(c), (d) or (e) of this Ordinance” are substituted therefor;

(c) section 6(9) thereof is repealed;

- (d) section 6(10) thereof is re-numbered as section 6(9);
- (e) immediately after section 10(1)(b) thereof there are inserted the word "or" and the following paragraphs—
- “(c) with intent to defraud, interferes with any mechanism or equipment used or to be used for the purposes of a draw; or
- (d) obstructs or impedes the conduct of a draw; or
- (e) creates any disturbance at or about the place where a draw is being or is about to be conducted;”;
- (f) in section 11(1) thereof—
- (i) in the definition of the expression “draw” there shall be inserted immediately after the word “drawing” the words “by computer or such other means as may be prescribed”;

- (ii) the definition of “Secretary” is deleted.

2. (1) This Ordinance may be cited as the Gambling (Channel Islands Lottery) (Bailiwick of Guernsey) (Amendment) Ordinance, 1986. Citation and collective title.

(2) This Ordinance and the Gambling (Channel Islands Lottery) (Bailiwick of Guernsey) Ordinances, 1975 and 1977 may be cited together as the Gambling (Channel Islands Lottery) (Bailiwick of Guernsey) Ordinances, 1975 to 1986.
