## **The Gambling (Crown and Anchor) (Guernsey) (Amendment) Ordinance, 2004**

**THE STATES LEGISLATION COMMITTEE**, in pursuance of the Resolution of the States of 27<sup>th</sup> November, 2003<sup>a</sup>, and in exercise of the powers conferred on the States by section 2 of the Gambling (Guernsey) Law, 1971, as amended<sup>b</sup> and on the Committee by Article 66(3) of the Reform (Guernsey) Law, 1948, as amended<sup>c</sup>, hereby orders:-

### **Amendment of the 1983 Ordinance.**

1. In section 4(3)(a) of the 1983 Ordinance delete “any Sunday,”.

### **Transitional provision.**

2. Notwithstanding the provisions of section 3(1) of the 1983 Ordinance, an application made pursuant thereto relating to the playing of a game of Crown and Anchor at an event which is to be held on 9<sup>th</sup> May 2004, may be delivered to the States Gambling Control Committee on or before 5<sup>th</sup> May 2004.

### **Interpretation.**

3. In this Ordinance, unless the context otherwise requires, “**the 1983 Ordinance**” means the Gambling (Crown and Anchor) (Guernsey) Ordinance,
