## The Export of Cattle Ordinance, 1950

**THE STATES**, in pursuance of their Resolution of the 5<sup>th</sup> day of April, 1950, hereby order: –

### **Restrictions on export of cattle.**

1. [(1) From the first day of April, 1952, and until such time as the States may by resolution otherwise appoint, the States [Committee for the Environment & Infrastructure] may, for the purpose of safeguarding the well-being of this community or of agriculture in this Island, at any time by order impose such restrictions as it may deem necessary on the export of any class of female bovine animals.]

(2) Any such order shall be published on a single occasion in La Gazette Officielle, and unless the order otherwise specifies, shall come into force on the day following the date of such publication.

(3) Any such order shall be laid before the States as soon as may be after the making thereof and if, at the meeting of the States in the course of which that order is laid before them or at the next subsequent meeting, the States resolve that the order be annulled, it shall cease to have effect, but without prejudice to anything previously done thereunder or to the making by the said Committee of a new order.

**Penalties.**

2. A person contravening or attempting to contravene the provisions of any such order as aforesaid shall be guilty of an offence and liable on conviction to a fine not exceeding [level 2 on the uniform scale] in respect of each animal exported or attempted to be exported in contravention of those provisions or to imprisonment for a term not exceeding six months or to both such fine and such imprisonment.

**Commencement.**

3. This Ordinance shall be deemed to have come into force on the 1<sup>st</sup> day of April, 1950.
