**The Marriage Fees (Guernsey) Regulations, 2010**

THE TREASURY AND RESOURCES DEPARTMENT, in exercise of the powers conferred on it by sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following regulations:-

**Amendment of fees**

1. The Marriage Fees (Guernsey) Ordinance, 1978<sup>b</sup> ("the 1978 Ordinance") is amended in accordance with the following provisions of these Regulations.

**Fee payable to officiating minister**

2. In section 2 of the 1978 Ordinance for "£6"<sup>c</sup> substitute "£7".

**Fees payable to Registrar-General etc**

3. For the schedule to the 1978 Ordinance<sup>d</sup> substitute the schedule set out in the schedule to these Regulations.

4. The Marriage Fees (Guernsey) Regulations, 2009<sup>e</sup> are repealed.


**Citation**

7	Attendance of Registrar in licensed building	£50.00
8	Attendance of Registrar in private house (except where paragraph 9 applies)	£65.00
9	Attendance of Registrar in private house or hospital etc. pursuant to section 2(bb) of the principal Law	£5.00"
