

The Water Charges (Amendment) Regulations, 2010

Made

10th December, 2010

Coming into operation

1st January, 2011

Laid before the States

THE PUBLIC SERVICES DEPARTMENT, in exercise of the powers conferred on it by section 17 of the Loi ayant rapport a la Fourniture d'Eau par les Etats de cette Ile aux Habitants de la dite Ile, 1927, as amended^a, sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007^b and all other powers enabling it in that behalf, hereby make these following Regulations:-

Increase in water charges for 2011.

1. For paragraphs 1 and 2 of the Schedule to the Water Charges Ordinance 1991^c, as amended, substitute the following paragraphs –

"1. The charges which may be made in 2011 under section 5 for a supply of water to a property by measure are –

- (a) a charge of £1.75 per cubic metre of water supplied,

- (b) the quarterly charge in column 2 below appearing opposite the size shown in column 1 of the meter which measures the property's supply.

1. Size of meter	2. Quarterly charge
15 mm (½")	£25.00
20 mm (¾")	£37.14
25 mm (1")	£41.16
40 mm (1½")	£46.31
50 mm (2")	£48.99
75 mm (3")	£51.47
100 mm (4")	£56.59

2. The charge which may be made in 2011 under section 4 or 6 for a supply of water for domestic purposes to a property otherwise than by measure is the quarterly charge in column 2 below and a quarterly charge of £0.46 multiplied by each assessable unit of the property as calculated for the purposes of property tax under the provisions of the Taxation of Real Property (Guernsey and Alderney) Ordinance, 2007^d.

1. Rate per assessable unit of TRP	2. Quarterly charge
£0.46	£25.00

Repeal and revocation.

2. (1) The Water Charges (Amendment) Ordinance, 2004^e is repealed.
- (2) The Water Charges (Amendment) (No.2) Regulations, 2009^f are revoked.

Interpretation.

3. (1) The Interpretation (Guernsey) Law, 1948^g applies to the interpretation of these Regulations.
- (2) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

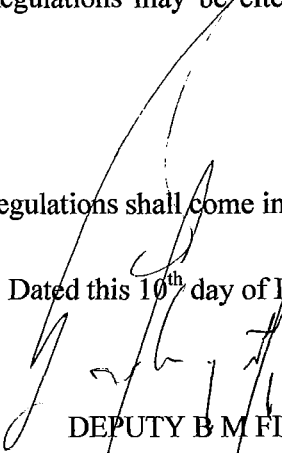
Citation.
