**The Health Service (Medical Appliances) (Amendment)
Regulations, 2010**

THE SOCIAL SECURITY DEPARTMENT, in exercise of the powers conferred upon it by sections 15, 16, 18 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990, as amended^a, hereby orders:-

Amendment.

1. For the Third Schedule to the Health Service (Medical Appliances) Regulations, 1990, as amended^b substitute the schedule set out in the Schedule to these Regulations.

Interpretation.

2. (1) Except where the context otherwise requires, any reference in these Regulations to any enactment or regulations shall be construed as including a reference to that enactment or those regulations, as the case may be, as amended, repealed, replaced, revoked, extended or applied, by or under any other enactment or by any other regulations.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of these regulations as it applies to the interpretation of a Guernsey enactment.

Revocation of 2009 Regulations.


3. The Health Service (Medical Appliances) (Amendment) Regulations, 2009 are revoked^d.

Citation, commencement and extent.

4. (1) These Regulations may be cited as the Health Service (Medical Appliances) (Amendment) Regulations, 2010 and shall come into operation on the 1st January, 2011.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport).

These Regulations further amend the Health Service (Medical Appliances) Regulations, 1990, as amended, by increasing the charges payable to authorised appliance suppliers in Guernsey and Alderney by persons supplied with Part I, II or III medical appliances, who are not exempt from such charges.
