THE POLICY COUNCIL, in exercise of the powers conferred on it by sections 49 and 54 of the Criminal Justice (Proceeds of Crime) (Bailiwick of Guernsey) Law, 1999^a hereby makes the following Regulations –

Amendment of regulation 5 of the Principal Regulations.

1. In regulation 5(1)(c)(ii) of the Principal Regulations, immediately after the word "notices", insert ", instructions".

Interpretation.

2. (1) In these Regulations, "the Principal Regulations" means the The Criminal Justice (Proceeds of Crime) (Financial Services Businesses) (Bailiwick

of Guernsey) Regulations, 2007^b.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation.

3. These Regulations may be cited as the Criminal Justice (Proceeds of Crime) (Financial Services Businesses) (Bailiwick of Guernsey) (Amendment) Regulations, 2010.


Commencement.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend regulation 5(1)(c)(ii) of the Criminal Justice (Proceeds of Crime) (Financial Services Businesses) (Bailiwick of Guernsey) Regulations, 2007 so that a financial services business is required to carry out enhanced customer due diligence in relation to business relationships which the business considers to be high risk, taking into account instructions issued by the Guernsey Financial Services Commission.
