**The Health Service (Benefit) (Limited List) (Pharmaceutical Benefit)
(Amendment No. 2) Regulations, 2008**

THE SOCIAL SECURITY DEPARTMENT, in exercise of the powers conferred upon it by sections 10 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990 as amended¹, section 1 of the Health Service (Benefit) (Limited Lists) Ordinance, 2004² and of all other powers enabling it in that behalf, hereby orders:-

Amendment

1. In the Schedule to the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) Regulations, 2004³, as amended, add the rows set out in Schedule 1 to these Regulations, under the appropriate headings.

Extent

2. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Interpretation

3. The Interpretation (Guernsey) Law, 1948⁴ applies to the interpretation of these Regulations as it applies to the interpretation of a Guernsey enactment.

Citation

4. These Regulations may be cited as the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) (Amendment No. 2) Regulations, 2008.


