

**The Boats and Vessels (Registration Number Display
Requirements) Order, 2010**

THE STATES OF GUERNSEY PUBLIC SERVICES DEPARTMENT, in exercise of the powers conferred on it by section 18(3) of the Boats and Vessels (Registration, Speed Limits and Abatement of Noise) Ordinance, 1970 as amended^a and all other powers enabling it in that behalf, hereby orders:-

Amendment of section 5 of the 1970 Ordinance.

1. In section 5 of the Boats and Vessels (Registration, Speed Limits and Abatement of Noise) Ordinance, 1970 as amended ("**the 1970 Ordinance**"), for the words from "painted or marked" to the end of paragraph (b), substitute –

"painted or marked on the boat as follows –

- (a) in the case of such a boat as aforesaid which is not a personal watercraft: on the exterior of the hull at the transom or the extreme after end of the boat, in accordance

with the requirements specified in the First Schedule, or, in the case of a speedboat, the Second Schedule,

- (b) in the case of such a boat as aforesaid which is a personal watercraft: on both left and right sides of the fore deck, in accordance with the requirements specified in the First Schedule,".

Amendment of the Schedules to the 1970 Ordinance.

- 2. (1) For the First Schedule to the 1970 Ordinance, substitute the following –

"FIRST SCHEDULE

Section 5.

Requirements as to numbers on all personal watercraft, and other boats except speedboats, registered under Part I of this Ordinance

- 1. The number shall be of a distinctive colour compared with the colour of the hull (or, in the case of personal watercraft, the colour of the surrounding background).

- 2. Each numeral shall be at least six inches high."

- (2) For the heading of the Second Schedule to the 1970 Ordinance, substitute the following –

"SECOND SCHEDULE

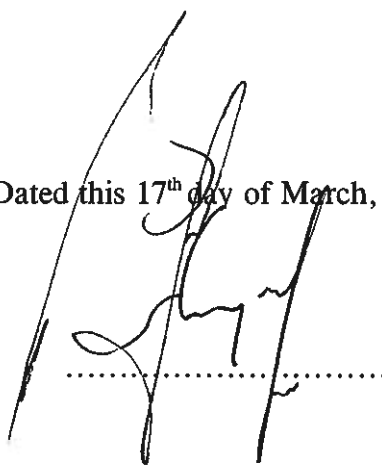
Section 5.

Requirements as to numbers on speedboats (except personal watercraft) registered under Part I of this Ordinance"

Citation and Commencement.

3. This Order may be cited as the Boats and Vessels (Registration Number Display Requirements) Order, 2010, and shall come into force on 1st April 2010.
