**The Financial Services Commission (Bailiwick of Guernsey)
(Amendment) Regulations, 2009**

THE GUERNSEY FINANCIAL SERVICES COMMISSION, in exercise of the powers conferred on it by sections 24(1) and 25 of the Financial Services Commission (Bailiwick of Guernsey) Law, 1987^a and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the Financial Services Commission (Bailiwick of Guernsey) Law, 1987.

1. In the definition of "regulatory Laws" under section 24(1) of The Financial Services Commission (Bailiwick of Guernsey) Law, 1987, as amended insert the following paragraph –

"(g) The Registration of Non Regulated Financial Services Businesses Law, 2008."

Interpretation.

2. (1) In these Regulations, unless the context requires otherwise -

"**enactment**" means any Law, Ordinance or subordinate legislation, and

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any enactment and having legislative effect.

(2) The Interpretation (Guernsey) Law, 1948^b applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation and commencement.

3. These Regulations may be cited as the Financial Services Commission (Bailiwick of Guernsey) (Amendment) Regulations, 2009 and shall come into force on the 8th June, 2009.
