THE IMMIGRATION (CONTROL AFTER ENTRY) (E.E.C. AND OTHER NON-
COMMONWEALTH NATIONALS) (AMENDMENT) (GUERNSEY) RULES 1976

Made 18 May 1976 .

Laid before the States 1976 .

Coming into operation . 19 May 1976 .

The STATES BOARD OF ADMINISTRATION, in exercise of the powers conferred upon it by subsection (2) of section three of the Immigration Act 1971, as extended to the Bailiwick by the Immigration (Guernsey) Order 1972, hereby makes the following Rules:-

Amendments to Rules of 1973

1. The Immigration (Control After Entry) (E.E.C. and Other Non-Commonwealth Nationals) (Guernsey) Rules, 1973 (a), are hereby amended as follows:-

- (a) paragraphs 6, 23, 24 and 38 thereof are repealed and the following new paragraphs are respectively substituted therefor:-

Crew Members

6. A person who has been given leave to enter to join a ship or an aircraft as a member of its crew, or a crew member who has been given leave to enter for hospital treatment, repatriation or transfer to another ship or aircraft in the Bailiwick, should be granted an extension of stay only when this is necessary to fulfil the purpose for which he was given leave to enter, unless he qualifies for the removal of the time limit on his stay in accordance with paragraphs 22 or 23.

Marriage

23. A man admitted in a temporary capacity who marries a woman settled here may on application have the time limit on his stay removed.

24. Fiances arriving with entry clearances for the purpose of marriage to a woman settled here are normally admitted for 3 months. On receipt of satisfactory evidence that the marriage has taken place, the time limit may be removed.

Families

38. Members of the family of a person to whom paragraphs 34 to 37 apply should be granted extensions of stay or issued with residence permits in the same terms as those relating to that person at the time in question. The family should be regarded as consisting of the person's spouse, their children under 21, their other dependent children, and their dependent parents and grandparents. ;

(b) in paragraphs 2, 11, 29 and 58 thereof the words "Immigration Office" are hereby repealed and the words "Immigration and Nationality Department" are hereby substituted therefor.

Citation

2. These Rules may be cited as the Immigration (Control After Entry) (E.E.C. and Other Non-Commonwealth Nationals)(Amendment)(Guernsey) Rules 1976.

Commencement

3. These Rules shall come into force on the nineteenth day of May, nineteen hundred and seventy-six.

EXPLANATORY NOTE

These Rules make provision for certain changes as to the practice to be followed in the administration of the Immigration Act 1971, as extended to the Bailiwick of Guernsey, for regulating the stay in the Bailiwick of nationals of Member States of the European Economic Community (including the Republic of Ireland), nationals of foreign States outside the Community and Stateless persons. Provision is also made regarding the change of name of the Department concerned in these matters. Any reference to a time factor or to a duration of stay has been included with the concurrence of the Lieutenant-Governor whose concurrence has also been given with regard to the directions contained herein attached to the variation, extension, removal or curtailment of any limit imposed upon the length of time a person has leave to enter or remain in the Bailiwick.
