The Parking Places (Amendment) Order, 1975

Made the 26th day of August, 1975,

Coming into force on the 29th August, 1975.

THE ISLAND POLICE COMMITTEE, in pursuance of the powers vested in it by section one of the Road Traffic (Parking Places) Ordinance, 1963(a), and of all other powers enabling it in that behalf, hereby orders:-

1.. The Parking Places Order, 1968, as amended(b), is hereby further amended as follows:-

- (a) section six thereof is repealed and the following section is substituted therefor -

" 6. A person, being in charge of a public vehicle, shall not park that vehicle in any disc parking place or approved parking place except when that vehicle is on hire to a passenger:

Provided that -

- (a) in the case of a public vehicle in respect of which there is in force a taxi licence, such person may park that vehicle -
- (i) in any of the approved parking places Nos. A4, A6, A7 or A49, for the purposes of standing or plying for hire;
- (ii) on the west side of the area of the road comprised in approved parking place No. A7 between the hours of midnight of any day and midnight of the day next following for any continuous period not greater than a period of one hour for purposes other than standing or plying for hire;
- (b) in the case of a public vehicle in respect of which there is in force a private hire motor car licence, such person may park that vehicle in any of the disc parking places specified in paragraphs (a), (b) or (c) of section nine of this Order in accordance with the provisions of the said paragraphs (a), (b) or (c), as the case may be, regulating the parking of vehicles in any such disc parking place, notwithstanding that the vehicle is not on hire to a passenger."

- (b) in subsection (3) of section eight thereof the word, letters and figures "A3, A4, A5, A6, A7 or A49" are repealed and the word, letters and figures "A4, A6, A7 or A49" are substituted therefor and immediately thereafter the following proviso is inserted -

"Provided that in the case of a public vehicle in respect of which there is in force a taxi licence, such person may park that vehicle on the west side of the area of the road comprised in approved parking place No. A7 for purposes other than standing or plying for hire in accordance with the provisions of paragraph (ii) of proviso (a) to section six of this Order.";

- (c) in paragraph (b) of section nine thereof -

- (i) the letter and figures "D17" are repealed;
- (ii) the word, letters and figures "D86 and D87" are repealed and the word, letters and figures "D86, D87 and D97" are substituted therefor;

- (d) in paragraph (d) of section nine thereof -

- (i) the letter and figures "D76" are repealed;
- (ii) the word, letters and figures "D79 and D91" are repealed and the word, letters and figures "D91, D98, D99 and D100" are substituted therefor;

- (e) in paragraph (e) of section nine thereof the word, letters and figures "D53 and D54" are repealed and the word, letters and figures "D53, D54, D103 and D104" are substituted therefor;

- (f) in paragraph (g) of section nine thereof -

- (i) immediately after the letter and figures "D58" there are inserted the letter and figures "D76";
- (ii) immediately after the letter and figures "D77" there are inserted the letter and figures "D79";
- (iii) the word, letters and figures "D93 and D94" are repealed and the word, letters and figures "D93, D94, D95, D96, D101, D102 and D105" are substituted therefor;

- (g) in section sixteen thereof -

- (i) immediately after the definition of the expression "police officer" there is inserted the following additional definition -

" "private hire motor car licence" has the meaning assigned to it by section fifty of the Public Transport Licensing Ordinance, 1966;"

- (ii) immediately after the definition of the expression "public vehicle" there is inserted the following additional definition -

" "taxi licence" has the meaning assigned to it by section fifty of the Public Transport Licensing Ordinance, 1966;"

(h) immediately after section sixteen thereof there is inserted the following additional section numbered "16A" -

" 16A. Except where the context otherwise requires, any reference in this Order to any enactment shall be construed as including a reference to that enactment as amended, repealed and replaced, extended or applied by or under any other enactment.";

- (i) in the entry relating to disc parking place No D10 in the third column of Part I of the First Schedule thereto the words, letters and figures "but excluding approved parking places Nos. A2 and A3" are repealed and the words, letter and figure "but excluding approved parking place No. A2" are substituted therefor;
- (j) the entries relating to disc parking place No. D17 in each of the columns of Part I of the First Schedule thereto are repealed;
- (k) the entry relating to disc parking place No. D90 in the third column of Part I of the First Schedule thereto is repealed and the entry "The seaward side of the road between parking signs placed as near as may be to the premises known as the Half Moon Restaurant." is substituted therefor;
- (l) immediately after the entries relating to disc parking place No. D94 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the First Schedule to this Order;
- (m) the entries relating to approved parking places Nos. A3, A5 and A50 in each of the columns of Part II of the First Schedule thereto are repealed;
- (n) in the entry relating to approved parking place No. A4 in the third column of Part II of the First Schedule thereto the words "The portion of" are repealed;
- (o) immediately after the entries relating to approved parking place No. A49 in each of the columns of Part II of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Second Schedule to this Order;
- (p) immediately after the entries relating to approved parking place No. 11B 15 in each of the columns of Part III of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Third Schedule to this Order.
2. This Order may be cited as the Parking Places (Amendment) Order, 1975.
3. This Order shall come into force on the twenty-ninth day of August, nineteen hundred and seventy-five.

"	D95	Saint George's Esplanade, Saint Peter Port.	The seaward side of the road between a parking sign placed as near as may be opposite Piette Road and a parking sign placed as near as may be opposite Bouillon Lane.
	D96	Piette Road, Saint Peter Port.	The west side of the road between a parking sign placed as near as may be to its junction with Saint George's Esplanade and a parking sign placed as near as may be opposite New Paris road.
	D97	Allez Street, Saint Peter Port.	The south east side of the road between a parking sign placed as near as may be to its junction with George Street and a parking sign placed as near as may be to its junction with Vauvert.
	D98	Hauteville, Saint Peter Port.	The east side of the road between a parking sign placed as near as may be to the Water Pump and a parking sign placed as near as may be to the premises known as the Pandora Hotel at Nos. 50-54 Hauteville.
	D99	Hauteville, Saint Peter Port	The east side of the road between a parking sign placed as near as may be to its junction with Havelet and a parking sign placed as near as may be to the premises known as No. 78 Hauteville.
	D100	Hauteville, Saint Peter Port	The west side of the road between a parking sign placed as near as may be to the premises known as the Dorset Arms and a parking sign placed as near as may be to the premises known as No. 75 Hauteville.
	D101	La Walette, Saint Peter Port.	The seaward side of the road between a parking sign placed as near as may be to the south east extremity of Third Beach and a parking sign placed as near as may be to the entrance to the Horseshoe Pool but excluding approved parking place No. MB16.
	D102	La Valetto, Saint Peter Port	The landward side of the road between a parking sign placed as near as may be opposite the rock outcrop to the west of the Gentlemen's Pool and a parking sign placed as near as may be opposite the Horseshoe Pool.

D103	La Valette, Saint Peter Port.	The seaward side of the road between a parking sign placed as near as may be to the rock outcrop to the south of the Horseshoe Pool and a parking sign placed as near as may be to the entrance to the Mixed Bathing Pool.
D104	La Valette, Saint Peter Port.	The seaward side of the road between a parking sign placed as near as may be to the entrance to the Mixed Bathing Pool and a parking sign placed as near as may be to the Aquarium.
D105	Mignot Plateau, Saint Peter Port.	The whole area within the limits indicated by parking signs. "

A51	The unnamed road lying between North Quay and Trafalgar Road (otherwise known as Longrée), Vale.	The west side of the road between a parking sign placed as near as may be to its junction with Trafalgar Road and a parking sign placed as near as may be to the States Weighbridge. "

MB16	La Valette, Saint Peter Port.	The portion of the seaward side of the road near the Gentlemen's Pool indicated by parking signs as being reserved for motor bicycles.
MB17	La Valette, Saint Peter Port.	The portion of the seaward side of the road near the Mixed Bathing Pool indicated by parking signs as being reserved for motor bicycles. "
