THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections thirteen, fourteen, fifteen, sixteen, eighteen, nineteen, twenty-eight and sixty-eight of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-
