**The Health Service (Benefit) (Limited List) (Pharmaceutical Benefit)
(Amendment) (No. 3) Regulations, 2009**

Made 11th August 2009
Laid before the States
Coming into operation 1st September 2009

THE SOCIAL SECURITY DEPARTMENT, in exercise of the powers conferred upon it by sections 10 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990 as amended¹, section 1 of the Health Service (Benefit) (Limited Lists) Ordinance, 2004² and of all other powers enabling it in that behalf, hereby orders:-

Amendments.

1. The Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) Regulations, 2004, as amended³ are further amended as follows:

(a) for the heading to Regulation 2, substitute:

"Limited list for purposes of pharmaceutical benefit (medical practitioners)."

(b) In Regulation 2, delete "or dentists, as the case may be,";

(c) After Regulation 2, insert the following regulation:

"Limited list for purposes of pharmaceutical benefit (dentists)."

2A. The description, nature and quantity of drugs and medicines available as pharmaceutical benefit and which may be ordered to be supplied by medical prescriptions issued by dentists are restricted to the description, nature and quantity specified in the Dental Practitioners' Formulary as published from time to time in the British National Formulary."

Extent.

2. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Interpretation.

3. The Interpretation (Guernsey) Law, 1948⁴ applies to the interpretation of these Regulations as it applies to the interpretation of a Guernsey enactment.


Citation.

4. These Regulations may be cited as the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) (Amendment) (No. 2) Regulations, 2009.

Commencement.

5. These Regulations shall come into operation on the 1st day of September 2009.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport)

These Regulations amend the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) Regulations, 2004, which prescribe a limited list of drugs and medicines available as pharmaceutical benefit which may be ordered to be supplied by medical prescriptions issued by medical practitioners and dentists. The amendment restricts the description, nature and quantity of drugs and medicines available as pharmaceutical benefit, and which may be ordered to be supplied by medical prescriptions issued by dentists, to those specified in the Dental Practitioners' Formulary as published from time to time in the British National Formulary.
