The Health Service (Pharmaceutical) (Payment of Approved Suppliers)  
(Amendment) (No.3) (Guernsey) Regulations, 1975

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section twelve of the Health Service (Pharmaceutical) (Guernsey) Law, 1972, and of all other powers enabling it in that behalf, hereby orders -

Interpretation

1. (1) In these regulations, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them, that is to say :-

"basic price", in relation to the ingredients of any item of pharmaceutical benefit, has the same meaning as is assigned to that expression by paragraph (3) of regulation two of the principal regulations for the purpose of paragraph (1) of that regulation;

"the Law" means the Health Service (Pharmaceutical) (Guernsey) Law, 1972;

"the principal regulations" means the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Guernsey) Regulations, 1972;

and any other expressions have the same meanings as in the Law.

(2) Except where the context otherwise requires, any reference in these regulations to any enactment or regulations shall be construed as including a reference to that enactment or those regulations, as the case may be, as amended, repealed, replaced, revoked, extended or applied, by or under any other enactment or by any other regulations.

(3) The Interpretation (Guernsey) Law, 1948, shall apply to the interpretation of these regulations as it applies to the interpretation of a Guernsey enactment.

Additional supplemental payment to approved suppliers

2. An approved supplier shall be paid out of the Guernsey Health Service Fund in respect of each item of pharmaceutical benefit -

- (a) which was supplied by him under the Law during the period commencing on the fourth day of June, nineteen hundred and seventy-three, and ending on the thirtieth day of April, nineteen hundred and seventy-five; and

- (b) in respect of which payment was made out of that Fund upon the receipt by the Authority of a certificate relating to any part of that period and issued by the body appointed by the Authority to calculate the sum payable to approved suppliers in respect of pharmaceutical benefit supplied by them under the Law;

in addition to that payment and in addition to any supplemental payment made to him under regulation three of the Health Service (Payment of Approved Suppliers) (Amendment) (No.2) (Guernsey) Regulations, 1975, a sum equal to six per centum of the basic price of the ingredients of that item.

Repeal

3. Paragraph (2) of regulation two of the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Amendment) (No.2) (Guernsey) Regulations, 1975 is hereby repealed.


Citation, collective title and commencement

4. (1) These regulations may be cited as the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Amendment) (No.3) (Guernsey) Regulations, 1975.

(2) These regulations, the principal regulations, the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Amendment) (Guernsey) Regulations, 1975 and the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Amendment) (No.2) (Guernsey) Regulations, 1975, may be cited together as the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Guernsey) Regulations, 1972 to 1975.

- (3) These regulations shall come into operation on the twenty-ninth day of September, nineteen hundred and seventy five.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport).

These regulations further amend the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Guernsey) Regulations, 1972, so as to provide for an additional supplemental payment to be made to approved suppliers out of the Guernsey Health Service Fund in respect of drugs and medicines supplied by them between the 4th June, 1973 and the 30th April, 1975.
