**The Companies (Inspection and Copying of Documents)
(Fees) Regulations, 2009**

THE COMMERCE AND EMPLOYMENT DEPARTMENT, in exercise of the powers conferred on it by sections 127, 144, 535 and 538 of the Companies (Guernsey) Law, 2008¹ and all other powers enabling it in that behalf, hereby makes the following regulations:-

Fees for inspection of register and index of members.

1. The maximum fee prescribed for the purposes of section 127(1)(b) of the Companies (Guernsey) Law, 2008 for the inspection of a company's register and index of members by a person who is not a member or director of the company is

- (a) £10 for the request to inspect, and
- (b) £5 per hour or part thereof during which the right

of inspection is exercised.

Fees for copying of register of members.

2. (1) The maximum fee prescribed for the purposes of section 127(2) of the Companies (Guernsey) Law, 2008 for the copying of a company's register of members or any part of it is -

- (a) £1 for each of the first 5 entries in the register,
- (b) £30 for the next 95 entries (or part thereof),
- (c) £30 for the next 900 entries (or part thereof),
- (d) £30 for the next 99,000 entries (or part thereof),
and
- (e) £30 for the remainder of the entries (or part thereof).

(2) In addition, and should the recipient so request, the company may in its absolute discretion provide the copy of the register of members or any part of it in electronic form, subject to the payment of the fees set out in paragraphs (a) to (e) above.

Fees for inspection of register of directors.

3. The maximum fee prescribed for the purposes of section 144(1)(b) of the Companies (Guernsey) Law, 2008 for the inspection of a company's register of directors by a person who is not a member or director of the company is -

- (a) £10 for the request to inspect, and

- (b) £5 per hour or part thereof during which the right of inspection is exercised.

Fees for copying of register of directors.

4. The maximum fee prescribed for the purposes of section 144(2) of the Companies (Guernsey) Law, 2008 for the copying of a company's register of directors or any part of it is £20.

Interpretation.

5. (1) In these Regulations, except where the context excludes, expressions have the same meaning as in the Companies (Guernsey) Law, 2008.

(2) References in these Regulations to an enactment are references thereto as from time to time amended, repealed and replaced (with or without modification), extended or applied.

(3) The Interpretation (Guernsey) Law, 1948² applies to the interpretation of these Regulations.

Repeal of 1999 Regulations.

6. The Company Documents (Inspection and Copying Fees) Regulations, 1999³ are repealed.

Citation.

7. These Regulations may be cited as the Companies (Inspection and Copying of Documents) (Fees) Regulations, 2009.

8. These Regulations shall come into force on the 1st December, 2009.

These regulations prescribe for the purposes of the Companies (Guernsey) Law, 2008 the fee payable by a person inspecting a company's register and index of members and by a person requiring a copy of a company's register of members.
