THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended¹, hereby orders:-

1. The Parking Places Order, 1991, as amended², is further amended as follows.
2. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA5, the words, "but excluding Approved Parking Place No. AC 17a." are inserted following the words "Route Charles".

In Part A of Schedule 2, the entry in the third column relating to Approved Parking Place No. AA40 is deleted and replaced with the words, "on the roads of the estate and including the tarmac areas to the north and adjacent to the south-east corner of the estate road, but excluding Approved Parking Place No. AC6."

4. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA42, the words, "and including the tarmac areas adjacent to the junction with Clairval Estate" are inserted following the words "of the estate".

5. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA57, the words, "and the tarmac area to the west of property Nos. 28 and 29" are inserted following the words "of the estate".

6. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA63, the words, "and the tarmac area to the east of property No. 11" are inserted following the words "of the estate".

7. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA64, the words, "and the tarmac area adjacent to Rue du Presbytere" are inserted following the words "of the estate".

8. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA67, the words, "and the raised area of tarmac to the east of property No. 24" are inserted following the words "of the estate".

9. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA69, the words, "and the tarmac areas to the north of property Nos. 53 to 70, to the south of property Nos. 65 to 70 and to the west of property No. 118" are inserted following the words "of the estate".

10. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC5g insert the following entry -

AC6	Courtil St Jacques Estate	The portion of the parking area to the north of the estate road as near as may be to No. 50 within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.


11. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC17 insert the following entry -

AC17a	Route Isabelle	The portion of the road to the west of its junction with Les Croutes, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.

12. This Order may be cited as the Parking Places (Amendment) (No. 4) Order, 2008.

13. This Order shall come into force on the ~~28th~~ ^{24th} December, 2008.
