STATUTORY INSTRUMENT 1976 No. 7

THE IMPORT DUTIES (BAILLIWICK OF GUERNSEY) (No. 71) ORDER, 1976

The Board of Administration, in pursuance of the powers conferred upon it by section two and section ten of the Import Duties Act (Bailiwick of Guernsey) 1932, as amended and in implementation of the obligations of the Bailiwick under the provisions of Protocol No. 3 annexed to the Treaty relating to the accession of the United Kingdom to the European Economic Community and to the European Atomic Energy Community, hereby orders:-

1. The Import Duties (Bailiwick of Guernsey) (No. 70) Order, 1975 (a) is hereby amended as follows:-

the rates of duty shown in the Second Schedule thereto in respect of the tariff headings set out in the Schedule to this Order are revoked and the rates of duty set out in the said Schedule in respect of those tariff headings are respectively substituted therefor.

2. The Interpretation (Guernsey) Law, 1948, shall apply to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.

3. (1) This Order may be cited as the Import Duties (Bailiwick of Guernsey) (No. 71) Order, 1976.

(2) This Order shall come into operation on the first day of March, nineteen hundred and seventy-six.

EXPLANATORY NOTE

This Order, which comes into operation on 1st March 1976, makes amendments to the Second Schedule annexed to the Import Duties (Bailiwick of Guernsey) (No.70) Order 1975, which sets out the 1976 Guernsey tariff.

The Schedule provides, in respect of products covered by the European Community's common organisation of the market in beef and veal (Article 59 (1) (a) of the Act of Accession), for

- (a) a fourth 20% reduction of duty in the case of goods qualifying for entry as EEC goods (symbol "M"); and for
- (b) the existing full rates to move towards the full rates of the EEC's Common Customs Tariff by a fourth 20% reduction of the difference between these rates as at the base date (1st January 1972).
