**The Water Charges (Amendment) (No.2)
Regulations, 2009**

THE PUBLIC SERVICES DEPARTMENT, in exercise of the powers conferred on it by section 17 of the Loi ayant rapport a la Fourniture d'Eau par les Etats de cette Ile aux Habitants de la dite Ile, 1927, as amended^a, section 1 of the Fees, Charges and Penalties (Guernsey) Law, 2007^b and all other powers enabling it in that behalf, hereby make these following Regulations:-

Increase in water charges for 2010.

1. For paragraphs 1 and 2 of the Schedule to the Water Charges Ordinance 1991^c, as amended, substitute the following paragraphs –

"1. The charges which may be made in 2010 under section 5 for a supply of water to a property by measure are –

- (a) a charge of £1.69 per cubic metre of water supplied,

- (b) the quarterly charge in column 2 below appearing opposite the size shown in column 1 of the meter which measures the property's supply.

1. Size of meter	2. Quarterly charge
15 mm (½")	£25.00
20 mm (¾")	£36.03
25 mm (1")	£39.93
40 mm (1½")	£44.92
50 mm (2")	£47.52
75 mm (3")	£49.93
100 mm (4")	£54.89

2. The charge which may be made in 2010 under section 4 or 6 for a supply of water for domestic purposes to a property otherwise than by measure is the quarterly charge in column 2 below and a quarterly charge of £0.44 multiplied by each assessable unit of the property as calculated for the purposes of property tax under the provisions of the Taxation of Real Property (Guernsey and Alderney) Ordinance, 2007^d.

1. Rate per assessable unit of TRP	2. Quarterly charge
£0.44	£25.00

Revocation.

2. (1) Paragraph 1 of the Water Charges (Amendment) Regulations, 2008^e is revoked.

(2) The Water Charges (Amendment) Regulations, 2009^f are revoked.

Interpretation.

3. (1) The Interpretation (Guernsey) Law, 1948^g applies to the interpretation of these Regulations.

(2) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.


Citation.
