**The States Housing (Rent and Rebate Scheme) (Guernsey)  
(Amendment) Regulations, 2008**

**THE HOUSING DEPARTMENT**, in exercise of the powers conferred on it by section 3(1) of the States Housing (Tenancies, Rent and Rebate Scheme) (Guernsey) Law, 2004<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following regulations:-

**Amendment to Regulations of 2005.**

1. The States Housing (Rent and Rebate Scheme) (Guernsey) Regulations, 2005<sup>b</sup> are amended as follows -

(a) In paragraph 10 (2) of Part V of the Appendix to the Third Schedule to the Regulations of 2005. –

(i) in subparagraph (a), for “£16.20” substitute “£20.00”,

- (ii) in subparagraph (b) (i), for “£16.20” substitute “£20.00”,
  - (iii) in subparagraph (b) (ii), for “£32.40” substitute “£40.00”,
  - (iv) in subparagraph (c), for “£16.20” substitute “£20.00”,
  - (v) in subparagraph (d), for “£16.20” substitute “£20.00”,
  - (vi) in subparagraph (e), for “£64.80” substitute “£80.00”,
  - (vii) in subparagraph (f), for “£48.60” substitute “£60.00”,
  - (viii) in subparagraph (h), for “£16.20” substitute “£20.00”,
  - (ix) in subparagraph (i), for “£32.40” substitute “£40.00”
- (b) in paragraphs 9(a) and (b) of the appendix to the Third Schedule to the Regulations of 2005, for "£5.25" substitute "£5.96".

**Revocation.**

2. (1) Regulation 1(e) of the States Housing (Rent and Rebate

Scheme) (Guernsey) (Amendment) Regulations, 2006<sup>c</sup> is revoked.

(2) The States Housing (Rent and Rebate Scheme) (Guernsey) (Amendment) Regulations 2007<sup>d</sup> are revoked.

**Interpretation.**

3. (1) In these Regulations, unless the context requires otherwise -

(a) **"the Regulations of 2005"** means the States Housing (Rent and Rebate Scheme) (Guernsey) Regulations, 2005, and

(b) other expressions have the same meanings as in the Regulations of 2005.

(2) The Interpretation (Guernsey) Law, 1948<sup>e</sup> applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment or regulations is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

**Citation and commencement.**

4. These Regulations may be cited as the States Housing (Rent and Rebate Scheme) (Guernsey) (Amendment) Regulations, 2008 and shall come into force on the 3 January 2009.
