The Driving Tests (Increase of Fees) Regulations, 2008

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by sections 2A(b) and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987, as amended ⁽¹⁾, hereby orders:-

Amendment to 1995 Ordinance

1. For Schedule 2 to the Driving Licences (Guernsey) Ordinance, 1995, as amended ⁽²⁾, substitute the following Schedule-

Driving test fees

The fee payable prior to taking a test of competence relating to a motor vehicle of a class included in the category set out in column (1) of the Table below shall be the corresponding sum set out in column (2) thereof.
