**The Health Service (Alderney Hospital Benefit) (Amendment)
Regulations, 2008**

Made 27th February 2008
Laid before the States
Coming into operation 1st March 2008

THE SOCIAL SECURITY DEPARTMENT, in exercise of the powers conferred upon it by Part IIIA and section 35 of the Health Service (Benefit) (Guernsey) Law, 1990, as amended¹, and as modified by the Health Service (Alderney Hospital Benefit) Ordinance, 1997, as amended², and of all other powers enabling it in that behalf, hereby orders:-

Amendment

1. The Schedule to the Health Service (Alderney Hospital Benefit) Regulations, 1997³ is revoked and replaced by the schedule set out in the Schedule to these Regulations.

Extent

2. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Interpretation

3. The Interpretation (Guernsey) Law, 1948⁴ applies to the interpretation of these Regulations as it applies to the interpretation of a Guernsey enactment.

4. These Regulations may be cited as the Health Service (Alderney Hospital Benefit) (Amendment) Regulations, 2008.

Commencement

5. These Regulations shall come into operation on the 1st day of March 2008.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport)

These Regulations provide for the list of exclusions in the Health Service (Alderney Hospital Benefit) Regulations, 1997, as amended, to accord with the Alderney Hospital Contract commencing on 1 March 2008.

Exclusions from Alderney Hospital Benefit

1. Initial treatment of patients in the casualty department of the Mignot Memorial Hospital;
2. Treatment of patients who have been admitted to the Mignot Memorial Hospital for elective rest for nursing home care at the patient's request;
3. Treatment of patients admitted to the Mignot Memorial Hospital where prior or subsequent treatment is excluded from the Medical Specialist Group Contract;
4. Treatment of patients admitted to the Mignot Memorial Hospital where immediately prior treatment as an inpatient, regardless of where such treatment took place, was undertaken on a private basis for the same condition;
5. General practice treatment.”
