**The Non-Contributory Pensions
(Implementation) (Amendment) (No. 2)
Ordinance, 1959**

THE STATES, in exercise of the powers conferred upon them by section three and section fourteen of the Non-Contributory Pensions (Guernsey) Law, 1955, and in pursuance of their Resolution of the first day of July, nineteen hundred and fifty-nine, and of all other powers enabling them in that behalf, hereby order:—

1. The Non-Contributory Pensions (Implementation) Ordinance, 1955, as amended (hereinafter referred to as "the principal Ordinance") is hereby further amended as follows:—

- (a) Items (a), (b) and (c) of paragraph 2 of Part I of the First Schedule to the principal Ordin-

ance are hereby repealed and the following items substituted therefor—

(b) Items (a) and (b) of paragraph 3 of Part I of the First Schedule to the principal Ordinance are hereby repealed and the following items substituted therefor—

“(a) For a husband and wife—		
(i) of whom one is such a person	94	0
(ii) of whom both are such persons	109	6
(b) For any other person, being—		
(i) aged twenty years or over	65	0

(ii) aged eighteen years or over but less than twenty years	47	0

2. The Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1957, and the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1958, and section two of the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1959, are hereby repealed.

3. This Ordinance, the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1959, and the principal Ordinance may be cited together as the Non-Contributory Pensions (Implementation) Ordinances, 1955 to 1959.

4. This Ordinance shall come into force on the sixteenth day of October, nineteen hundred and fifty-nine.
