**The Non-Contributory Pensions  
(Implementation) (Amendment) (No. 2)  
Ordinance, 1963**

THE STATES, in pursuance of their Resolution of the thirty-first day of July, nineteen hundred and sixty-three, and in exercise of the powers conferred upon them by section three and section fourteen of the Non-Contributory Pensions (Guernsey) Law, 1955(a), and of all other powers enabling them in that behalf, hereby order:—

1. The Non-Contributory Pensions (Implementation) Ordinance, 1955, as amended(b) (hereinafter referred to as “the principal Ordinance”) is hereby further amended as follows:—
