**The Non-Contributory Pensions
(Implementation) (Amendment)
Ordinance, 1962**

THE STATES LEGISLATION COMMITTEE, in pursuance of a Resolution of the States of the twenty-seventh day of June, nineteen hundred and sixty-two, in exercise of the powers conferred upon them by paragraph (3) of Article sixty-six of the Reform (Guernsey) Law, 1948, by section three and section fourteen of the Non-Contributory Pensions (Guernsey) Law, 1955, and of all other powers enabling them in that behalf, hereby order:—

1. The Non-Contributory Pensions (Implementation) Ordinance, 1955, as amended (hereinafter referred to as "the principal Ordinance") is hereby further amended as follows:—

(a) items (a), (b) and (c) of paragraph 2 of Part I of the First Schedule to the principal Ordinance are hereby repealed and the following items substituted therefor—

(b) For any other such person, being—	
(i) aged twenty years or over	69 0
(ii) aged eighteen years or over but less than twenty years	50 0

(iv) above school-leaving age but aged less than six- teen years	32 0'.

2. The Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1961, is hereby repealed. Repeal.

3. (1) This Ordinance may be cited as the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1962. Citation and collective title.

(2) This Ordinance, the Non-Contributory Pensions (Implementation) (Amendment) (No. 2) Ordinance, 1960, the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1959, and the principal Ordinance may be cited together as the Non-Contributory Pensions (Implementation) Ordinances, 1955 to 1962.

4. This Ordinance shall come into force on the twelfth day of October, nineteen hundred and sixty-two. Commencement.
