**The Non-Contributory Pensions
(Implementation) (Amendment)
Ordinance, 1964**

THE STATES, in pursuance of their Resolution of the twenty-ninth day of July, nineteen hundred and sixty-four, and in exercise of the powers conferred upon them by section three and section fourteen of the Non-Contributory Pensions (Guernsey) Law, 1955 (*a*), and of all other powers enabling them in that behalf, hereby order:—

1. The Non-Contributory Pensions (Implementation) Ordinance, 1955, as amended (*b*) (hereinafter referred to as “the principal Ordinance”) is hereby further amended, as follows:—

2. The Non-Contributory Pensions (Implementation) (Amendment) (No. 2) Ordinance, 1963 (*b*), is hereby repealed. Repeal.

3. (1) This Ordinance may be cited as the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1964. Citation and collective title.

(2) This Ordinance, the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1963 (*c*), the Non-Contributory Pensions (Implementation) (Amendment) (No. 2) Ordinance, 1960 (*d*), the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1959 (*e*), and the principal Ordinance may be cited together as the Non-Contributory Pensions (Implementation) Ordinances, 1955 to 1964.

4. This Ordinance shall come into force on the ninth day of October, nineteen hundred and sixty-four. Commencement.
