**The Non-Contributory Pensions  
(Implementation) (Amendment) Ordinance,  
1969**

THE STATES, in pursuance of their Resolution of the eighteenth day of December, nineteen hundred and sixty-eight, and in exercise of the powers conferred upon them by section three and section fourteen of the Non-Contributory Pensions (Guernsey) Law, 1955(a), and of all other powers enabling them in that behalf, hereby order:—

1. The Non-Contributory Pensions (Implementation) Ordinance, 1955, as amended(b) (hereinafter referred to as “the principal Ordinance”) is hereby further amended, as follows:—

2. The Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1968(c), is hereby repealed. Repeal.

3. (1) This Ordinance may be cited as the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1969. Citation and collective title.

(2) This Ordinance, the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1963(d), the Non-Contributory Pensions (Implementation) (Amendment) (No. 2) Ordinance, 1960(e), the Non-Contributory Pensions (Implementation) (Amendment) Ordinance, 1959(f), and the principal Ordinance may be cited together as the Non-Contributory Pensions (Implementation) Ordinances, 1955 to 1969.

4. This Ordinance shall come into force on the twenty-eighth day of February, nineteen hundred and sixty-nine. Commencement.
