### **The Official Publications (Amendment) Ordinance, 1965**

THE STATES LEGISLATION COMMITTEE, under and by virtue of the powers conferred upon them by paragraph (3) of Article sixty-six of the Reform (Guernsey) Law, 1948 (*a*), and in pursuance of section nine of the Law entitled "Loi par rapport à la publication des Annonces Officielles (1936)" registered on the twenty-first day of March, nineteen hundred and thirty-six (*b*), and of all other powers enabling them in that behalf, hereby order:—

1. The Ordinance entitled "Ordonnance par rapport à la Publication des Annonces Officielles" made on the twenty-first day of March, nineteen Amend-

hundred and thirty-six (c) (hereafter in this Ordinance referred to as “the principal Ordinance”) is hereby amended as follows, that is to say:—

- (a) in subsection (a) of section two thereof, the words “the newspapers known as Guernsey Evening Press and The Star” are hereby repealed and the words “the newspaper known as “Guernsey Evening Press and Star”” are hereby substituted therefor;
- (b) in subsection (b) of section two thereof—
  - (i) the words “the two newspapers” are hereby repealed and the words “the newspaper” are hereby substituted therefor;
  - (ii) the words “their respective offices” are hereby repealed and the words “their office” are hereby substituted therefor.

2. In the Official Publications Ordinance, 1948 (d), the words “of each of the newspapers known as “Guernsey Evening Press” and “The Star”” are hereby repealed and the words “of the newspaper known as “Guernsey Evening Press and Star”” are hereby substituted therefor.

Repeals.

3. The proviso to paragraph (a) of the principal Ordinance and the Official Publications Ordinance, 1950 (e), are hereby repealed.

Citation.

4. This Ordinance may be cited as the Official Publications (Amendment) Ordinance, 1965, and this Ordinance, the principal Ordinance, the Ord-

nance entitled "Ordonnance par rapport à la Publication des Annonces Officielles (1940)" made on the second day of March, nineteen hundred and forty (f), and the Official Publications Ordinance, 1948, may be cited together as the Official Publications Ordinances, 1936 to 1965.

5. This Ordinance shall come into force on the first day of November, nineteen hundred and sixty-five. Commence-  
ment.
