THE OCCUPIERS' RATE (LEVEL FOR 2004)
ORDINANCE, 2003

THE STATES OF ALDERNEY, in pursuance of their Resolution of the 19th day of December, 2003, and in exercise of the powers conferred upon them by section 3 of the Alderney (Application of Legislation) Law, 1948, as amended(a), hereby order:—

- 1. The Occupiers' Rate to be levied on any property in the calendar year 2004, pursuant to section 3 of the Alderney (Application of Legislation) Law, 1948, as amended, shall be levied at the rate of 260 pence in the pound of the rateable value of that property. **Level of Occupiers' Rate for 2004.**
- 2. This Ordinance may be cited as "The Occupiers' Rate (Level for 2004) Ordinance, 2003". **Citation.**

THE FEES (AMENDMENT) (No. 2) (ALDERNEY) ORDINANCE, 2003

The States of Alderney in pursuance of their Resolution of the 19th day of December 2003, and in exercise of all powers enabling them in that behalf, hereby order:-

- In Part I of The Fees (Alderney) Ordinance 1990, as substituted by the Fees (Amendment) (Alderney) Ordinance, 2003, add the following entry immediately after the entry relating to the Employment Permits (Alderney) Law, 1975: -
