THE STATES, on the representations of the States Advisory and Finance Committee and in pursuance of section ten of the Maintenance Orders (Facilities for Enforcement) (Guernsey) Law, 1955, hereby order:—

Reciprocating  
Countries.

1. Those parts of Her Majesty's dominions specified in the First Schedule to this Ordinance are hereby declared to be reciprocating countries for the

purposes of the Maintenance Orders (Facilities for Enforcement) (Guernsey) Law, 1955. 1959

2. The Ordinances set out in the Second Schedule to this Ordinance are hereby repealed.

3. This Ordinance may be cited as the Maintenance Orders (Facilities for Enforcement) (Reciprocating Countries) (Guernsey) Ordinance, 1959. Citation.
