**The Markets (Miscellaneous Provisions) (Repeal)
Ordinance, 2001**

THE STATES, in pursuance of their Resolution of the 27th day of November, 1997^a, hereby order:-

Repeal of Ordinances relating to the Market.

1. The following enactments are repealed -
