The Marriage Fees (Guernsey) Ordinance, 1978

THE STATES, in pursuance of their Resolution of the twenty-seventh day of July, nineteen hundred and seventy-seven, and in exercise of the powers conferred upon them by section three of the Marriage (Amendment) Law, 1951(a), and of all other powers enabling them in that behalf, hereby order:—

1. The fees payable to the Registrar General and, in the case of Sark, to the Deputy Registrar, in respect of and in connection with marriages shall be those set out in the Schedule to this Ordinance. Marriage Fees.

2. For each certified copy of the registration of a marriage transmitted to the Registrar General in accordance with the provisions of Article seven of the Law entitled "Loi ayant rapport aux Mariages célébrés dans les Iles de Guernesey, d'Auregny et de Serk" registered on the sixth day of May, nineteen Fees to officiating ministers for certified copies.
