## **The Milk (Control) (Amendment) (Guernsey) Ordinance, 1996.**

**THE STATES**, in pursuance of their Resolution of 28th February 1996(a) and in exercise of the powers conferred on them by sections 2 and 11 of the Milk and Milk Products (Guernsey) Law, 1955(b) and section 1 of the European Communities (Implementation) (Bailiwick of Guernsey) Law, 1994(c), hereby order:-

### Amendments to Milk Control Ordinance

1. In the Milk (Control) (Guernsey) Ordinance, 1958(d) as amended(e) -

(a) in section 1(1), immediately after the definition of "the Committee" insert:

"enactment" includes a Community instrument within the meaning of section 1(1) of the European Communities (Bailiwick of Guernsey) Law, 1973(f);

- (b) in section 4(2) for "thereto" substitute "in respect thereof";
- (c) immediately after section 4(2) insert:

"(2A) If any milk is delivered to the States Dairy which has not been produced at a holding, from cattle, and by methods, for the time being approved by the Committee as meeting the health conditions laid down in Council Directive 92/46/EEC (g) that milk must be classified as Grade 3 milk without applying any further tests in respect thereof."

**Citation**

2. This Ordinance may be cited as the Milk (Control) (Amendment) (Guernsey) Ordinance, 1996.

**Collective title**

3. This Ordinance and the Milk (Control) (Guernsey) Ordinances, 1958 to 1983 may be cited together as the Milk (Control) (Guernsey) Ordinances, 1958 to 1996.

**Commencement**

4. This Ordinance shall come into force on 1st July, 1996.
