The Public Holidays Ordinance, 1994

THE STATES, in pursuance of their Resolution of the 24th day of November, 1993(a), and in exercise of the powers conferred upon them by section 1(1) of the Bills of Exchange (Guernsey) Law, 1958, as amended(b), hereby order:-

Public Holidays.

1. The following days shall be public holidays-
 - (a) New Year's Day, if a weekday;
 - (b) the 2nd January, in a year when New Year's Day falls on a Sunday;
 - (c) Easter Monday;
 - (d) the first Monday in May;
 - (e) the 9th May, Liberation Day;

- (f) the last Monday in May;
- (g) the last Monday in August;
- (h) the 26th December, Boxing Day, if a weekday;
- (i) the 27th December, in a year when Christmas Day or Boxing Day falls on a Sunday;

and for the avoidance of doubt the expression "weekday" in this Ordinance includes a Saturday.

Amendment.

2. For Article I(1) of the Ordinance entitled "Ordonnance contenant les Règlements pour le Greffe" of the 25th October, 1930, as amended(c), substitute the following-

"(1) The Greffe shall be open, during the times specified in the Schedule hereto, on every day except Christmas Day, Good Friday and any day specified as a public holiday in section 1 of the Public Holidays Ordinance, 1994."

Repeals.

Extent.

4. This Ordinance shall have effect in the Islands of Guernsey, Herm and Jethou.

Citation.

5. This Ordinance may be cited as the Public Holidays Ordinance, 1994.
