The Patents, Designs and Trade Marks (Amendment) Ordinance, 1957

THE STATES, in pursuance of their Resolution of the sixteenth day of October, nineteen hundred and fifty-seven, and under and by virtue of the powers conferred upon them by section sixty of the Patents, Designs and Trade Marks Law (Guernsey), 1922, and of all other powers enabling them in that behalf, hereby order: –

Amendment of principal Ordinance.

1. The Ordinance entitled "Ordonnance ayant rapport à l'Enregistrement de Patentes, Dessins et Marques de Fabrique" made permanent on the eighteenth day of January, nineteen hundred and thirty-two (hereinafter referred to as "**the principal Ordinance**") is hereby amended as follows –

- (a) section one thereof is hereby repealed,
- (b) in paragraph (a) of section three thereof, the word "Cinq" is hereby deleted and the word "Deux" is hereby substituted therefor,¹
- (c) in paragraph (b) of section three thereof, the words "de Trois livres" are hereby deleted and the words "d'Une livre" are hereby substituted therefor,²
- (d) in paragraph (c) of section three thereof, the word "Trois" is hereby deleted and the word "Deux" is

hereby substituted therefor,³

(e) in paragraph (d) of section three thereof, the word "Cinq" is hereby deleted and the word "Deux" is hereby substituted therefor,⁴

(f) in paragraph (a) of section eight thereof the words "d'Une livre" are hereby deleted and the words "de Deux livres" are hereby substituted therefor,⁵

(g) in paragraph (b) of section eight thereof, the words "de Dix chelins" are hereby deleted and the words "d'Une livre" are hereby substituted therefor,⁶

(h) Schedule A thereto is hereby repealed.

2. There shall be paid to [Her Majesty's Greffier] the sum of [50 new pence] in respect of each notice of an application concerning a Patent or Trade Mark inserted in the notice box in the vestibule of the Royal Court.

NOTES

In section 2,

the words in the first pair of square brackets, and in the square brackets in the marginal note thereto, were substituted by the Patents, Designs and Trade Marks (Amendment) Ordinance, 1959, section 2, with effect from 1st January, 1960;

the words in the second pair of square brackets were substituted by the Decimal Currency (Bailiwick of Guernsey) Law, 1970, section 8, with

effect from 15th February, 1971.

Citation.

3. This Ordinance and the principal Ordinance may be cited together as the Patents, Designs and Trade Marks Ordinances, 1932 and 1957.

Commencement.

4. This Ordinance shall come into force on the first day of January, nineteen hundred and fifty-eight.
