**The Patents, Designs and Trade Marks  
(Amendment) Ordinance, 1959**

THE STATES, in pursuance of their Resolution of the twenty-ninth day of July, nineteen hundred and fifty-nine, and under and by virtue of the powers conferred upon them by section sixty of the Patents, Designs and Trade Marks Law (Guernsey), 1922, and of all other powers enabling them in that behalf, hereby order:—

1. The Ordinance entitled “Ordonnance ayant rapport à l’Enregistrement de Patentes, Dessins et Marques de Fabrique” made permanent on the eighteenth day of January, nineteen hundred and thirty-two, as amended, is hereby further amended as follows—

- (a) in section two thereof the words “et laquelle cause sera suivant la formule prescrite dans

- la Cédule B de cette Ordonnance” are hereby deleted;
- (b) in section four thereof the words “ et laquelle cause sera suivant la formule prescrite dans la Cédule C de cette Ordonnance ” are hereby deleted;
  - (c) in section six thereof the words “ et laquelle cause sera suivant la formule prescrite dans la Cédule D de cette Ordonnance ” are hereby deleted;
  - (d) section seven thereof is hereby repealed;
  - (e) in paragraph (b) of section nine thereof the words “ de Cinq chelins ” are hereby deleted and the words “ d’Une livre sterling ” are hereby substituted therefor;
  - (f) in paragraph (d) of section nine thereof the words “ Deux chelins six pennis ” are hereby deleted and the words “ Cinq chelins ” are hereby substituted therefor, and the words “ de 225 mots ” are hereby deleted;
  - (g) in subsection (2) of section ten thereof the words “ soit en Anglais soit en Français suivant à la Formulé contenue dans la Cédule F de cette Ordonnance ” are hereby deleted;
  - (h) the Schedules thereto are hereby repealed.

2. In section two of the Patents, Designs and Trade Marks (Amendment) Ordinance, 1957, the side heading thereto is hereby deleted and the following side heading is hereby substituted therefor—

“ Her Majesty’s Greffier’s fee ”

and in that section the words “ Her Majesty’s Sergeant ” are hereby deleted and the words “ Her Majesty’s Greffier ” are hereby substituted therefor.

3. This Ordinance and the Patents, Designs and Trade Marks Ordinances, 1932 and 1957, may be cited together as the Patents, Designs and Trade Marks Ordinances, 1932 to 1959.

4. This Ordinance shall come into force on the first day of January, nineteen hundred and sixty.
