**THE ROAD TRAFFIC (COMPULSORY THIRD-PARTY
INSURANCE) (ALDERNEY) ORDINANCE, 1973**

THE STATES, in pursuance of the powers conferred upon them by section twelve and section fourteen of the Road Traffic (Compulsory Third-Party Insurance) (Guernsey) Law, 1936, as amended, and as extended to the Island of Alderney by the Road Traffic (Compulsory Third-Party Insurance) (Alderney) Law, 1950, hereby order:-

Application of Ordinance to Alderney.

1. The Ordinance of the States of Guernsey set out in the left-hand column of the Schedule to this Ordinance shall, subject to the exceptions, adaptations and modifications set out in the right-hand column of that Schedule and subject to the provisions of the next succeeding section, have effect in the Island of Alderney as it has effect in the Island of Guernsey.

Substitution of references.

2. In the Ordinance having effect in the Island of Alderney by virtue of the provisions of the last preceding section, unless the context otherwise requires -

- (a) a reference to Guernsey shall be deemed to include a reference to Alderney and any cognate expression shall be construed accordingly;
- (b) a reference to any enactment shall be deemed to include a reference to that enactment as amended and as extended to the Island of

Alderney by any other enactment including this Ordinance.

Repeal.

3. The Road Traffic (Compulsory Third-Party Insurance) (Alderney) Ordinance, 1962, is hereby repealed.

Citation.

4. This Ordinance may be cited as the Road Traffic (Compulsory Third-Party Insurance) (Alderney) Ordinance, 1973.
