**The States Civil Service Board  
(Implementation) Ordinance, 1964**

THE STATES, in pursuance of their Resolution of the eleventh day of December, nineteen hundred and sixty-three, and in exercise of the powers conferred upon them by the Health, Safety and Welfare of Employees Law, 1950(a), Article 3 and Article 46 of the Mental Treatment Law (Guernsey) 1939(b), section two and section eight of the Poisonous Substances (Guernsey) Law, 1958(c) and section one of the Alderney (Application of Legislation) Law, 1948(d), and of all other powers enabling them in that behalf, hereby order:—

Ordinances amended.

1. The Ordinances set out in the left-hand column of the Schedule to this Ordinance are hereby amended or repealed, as the case may be, to the extent set out in the right-hand column of that Schedule.

Application to Alderney.

2. Section one of, and Part II of the Schedule to, this Ordinance shall have effect in the Island of Alderney as they have effect in the Island of Guernsey.

Citation.

3. This Ordinance may be cited as the States Civil Service Board (Implementation) Ordinance, 1964.
