### **The States Committee for Agriculture and Fisheries (Transfer of Functions) Ordinance, 1962**

THE STATES, in pursuance of their Resolution of the twenty-seventh day of June, nineteen hundred and sixty-two, hereby order:—

1. (1) The functions and powers vested in the States Committee for Agriculture and Fisheries and in the President thereof under and by virtue of the provisions of the Ordinances set out in the Schedule to this Ordinance are hereby transferred to and vested in the States Committee for Agriculture and the President thereof respectively.

(2) In addition to the functions and powers transferred and vested under the provisions of the preceding subsection there are also hereby so transferred and vested all rights and liabilities enjoyed by, or incumbent on, the said Committee for Agriculture and Fisheries and the President thereof in, or as a result of, the exercise of those functions or powers.

Savings

2. (1) Nothing done by, or in relation to, the said Committee for Agriculture and Fisheries or the President thereof under or as a consequence of the functions or powers transferred under the provisions of subsection (1) of the last preceding section before the coming into force of this Ordinance shall be invalidated by the coming into force thereof.

(2) Anything in process of being done under any of the provisions of the Ordinances referred to in section one of this Ordinance by, or in relation to, the said Committee for Agriculture and Fisheries or by the President thereof at the time of the coming into force of this Ordinance, whether by way of legal proceedings or otherwise, may be continued by, or in relation to, the States Committee for Agriculture or the President, as the case may be.

3. In section one of the Fishing (Exemption) Ordinance, 1961 (a), the words "Agriculture and" are hereby repealed and the word "Sea" is hereby substituted therefor.

4. This Ordinance may be cited as the States Committee for Agriculture and Fisheries (Transfer of Functions) Ordinance, 1962.
