THE STATES COMMITTEES (TRANSFER OF FUNCTIONS) (ALDERNEY) (AMENDMENT) ORDINANCE, 1999

THE STATES OF ALDERNEY, in exercise of the powers conferred upon them by section 1 of the Public Functions (Transfer and Performance) (Bailiwick of Guernsey) Law, 1991(a), and all other powers enabling them in that behalf, hereby order :—

1. In the States Committees (Transfer of Functions) (Alderney) Ordinance, 1997, as amended (b)— **Amendment of 1997 Ordinance.**

(a) after section 2 insert the following section—

“Transfer of functions to Building and Development Control Committee.

2A. Any function of a committee of the States of Alderney under an enactment set out in Schedule 3 is, from the date of the commencement of the States Committees (Transfer of Functions) (Alderney) (Amendment) Ordinance, 1999, transferred to the Building and Development Control Committee.”;

(b) after section 3 insert the following section—

“Savings and transitional provisions in relation to Building and Development Control Committee.

3A. Anything done before the date of the commencement of the States Committees (Transfer of Functions) (Alderney) (Amendment) Ordinance, 1999 or in the process of being done on that date by or in relation to a committee of The States of Alderney under an enactment set out in Schedule 3 shall have effect as if done or (as the case may be) may be continued by or in relation to the Building and Development Control Committee.”;

(c) in Part I of Schedule 1, paragraphs 3, 6, 9 and 11 are repealed;

(d) in Part II of Schedule 1, paragraph 5 is repealed;

(e) after Schedule 2, insert the following Schedule—
