The States Committees (Transfer of Functions) (Alderney) Ordinance, 1997

THE STATES OF ALDERNEY, in exercise of the powers conferred upon them by section 1 of the Public Functions (Transfer and Performance) (Bailiwick of Guernsey) Law, 1991^a, and all other powers enabling them in that behalf, hereby order: –

Transfer of functions to Policy and Finance Committee.

1. Any function of a committee of the States of Alderney under an enactment set out in Schedule 1 is transferred to the Policy and Finance Committee.

The following Regulations have been made under this Ordinance:

Traffic (Amendment) Regulations, 1998.

Transfer of functions to General Services Committee.

2. Any function of a committee of the States of Alderney under an enactment set out in Schedule 2 is transferred to the General Services Committee.

[Transfer of functions to Building and Development Control Committee.

2A. Any function of a committee of the States of Alderney under an enactment set out in Schedule 3 is, from the date of the commencement of the States Committees (Transfer of Functions) (Alderney) (Amendment) Ordinance, 1999, transferred to the Building and Development Control Committee.]

Savings and transitional provisions.

3. Anything done before the date of the commencement of this Ordinance or in the process of being done on that date by or in relation to a committee of the States of Alderney –

- (a) under an enactment set out in Schedule 1, shall have effect as if done or (as the case may be) may be continued by or in relation to the Policy and Finance Committee,
- (b) under an enactment set out in Schedule 2, shall have effect as if done or (as the case may be) may be continued by or in relation to the General Services Committee.

[Savings and transitional provisions in relation to Building and Development Control Committee.

3A. Anything done before the date of the commencement of the States Committees (Transfer of Functions) (Alderney) (Amendment) Ordinance, 1999 or in the process of being done on that date by or in relation to a committee of the States of Alderney under an enactment set out in Schedule 3 shall have effect as if done or (as the case may be) may be continued by or in relation to the Building and Development Control Committee.]

Interpretation.

4. (1) References in this Ordinance to an enactment are references thereto as amended.

(2) The provisions of the Interpretation (Guernsey) Law, 1948^b shall apply to the interpretation of this Ordinance.

(3) Expressions used in this Ordinance shall have the same respective meanings as in the Public Functions (Transfer and Performance) (Bailiwick of Guernsey) Law, 1991.

(4) References in this Ordinance to a committee of the States of Alderney include references to any member or officer of the committee.

Citation.

5. This Ordinance may be cited as the States Committees (Transfer of Functions) (Alderney) Ordinance, 1997.
